President Brent McCoy called the meeting to order at 7:15 p.m. The meeting was preceded by a social hour and dinner.

Officer's Reports

President's Report. Brent noted that 2012 was an eventful year. At the beginning of the year, the club was in dire financial straits, so severe that we had been forced to cancel our fall 2011 hunt test for lack of funds. We came into the year with a balance of \$1,259.38 and ended it with a solid balance of \$9,393.32. Brent commented that this turnaround was the result of many, many people in the club who worked very hard, by volunteering time and their own money, to help the club out. Kudos go to Roberta for doing so much, especially with regard to our hunt tests; to Carol for getting the judges lined up; to Mike for handling the awards; to Chuck for being our treasurer so capably; to Karen for her secretarial work. Thanks to many, many others as well, including Lois Eller, Mark and Patti Gibson for help with food, Kelley and Robert for handling the ducks, to Guy for his help with the equipment, to various people for supplying food for the judges' dinners and the club tests – Brent stated that he was sure that he hadn't mentioned all the names he needed to, but thanks to everyone.

Reading of the Minutes/Secretary's Report. The minutes from the last meeting were amended and approved via Email, and have been posted for a month on the ETRC website. Ken Wade moved, and John Guinn seconded, that we dispense with reading the minutes and formally approve the version posted on the website for the record. The motion carried unanimously.

Treasurer's Report. Chuck Atchley brought along the final report for 20112. The report, which is already posted on the website along with the January 23 minutes, shows all expenses and income for the year. A number of renewals and at least one new member application were handed in during the evening, so our bank balance will change significantly on Monday. As of February 22, our balance was \$9,602.32.

Old Business

Spring Hunt Test:

The test is scheduled for Memorial Day weekend as usual. Judges have been contracted and we are waiting final approval from AKC on some of them. Carol assures us that they are all "Fun People." We need lots of workers. David Knott agreed to be Chief Marshal for this test.

Fall Hunt Test:

We still have issues with our dates/locations for this test. Brent called for anyone who had any ideas to contact Mike or Roberta about possible locations other than Hiwassee, which is not available.

New Business

New Members:

Karen Edwards announced that we have three new members who are up for final approval tonight. They are:

Mike Evans moved that all three be admitted to full membership. Chuck Atchley seconded the motion, which was unanimously approved.

First Club Test

Roberta has received the renewal application from Equisure and will fill it out with the agreed-upon date and get it to Chuck for payment.

AKC News:

Brent reported that the Board had been asked to vote on some proposed changes to Field Trial rules. We had reviewed the changes, discussed them, and voted No. The ballot was submitted by ETRC Secretary Karen Edwards to the AKC.
