

### Training Session 2/26/22: Field Trial Seminar & Setups



# February 26, 1:00 p.m. Satuday: Mini-Seminar & Setups: Field Trials.

This event will be held at Brady Collins' training property, 1500 Dogtown Road, Ten Mile, TN (South of Kingston & Midway, just off Hwy 58). The aerial view to the left shows the layout of the property.

Have you ever wondered about the difference between Hunt Tests and Field Trials? Here is your opportunity to find out!

Pro Field Trial Trainer Brady Collins will explain the differences, demonstrate particular points with his dogs, and then provide setups and coaching so we can try it out with our own dogs. Members and active field trialers Jake Greenwell and John Broucek will also assist. Brady will supply bird technicians and frozen ducks will be used for marks and blinds.

Topics to be covered include the following:

- 1. Overview of AKC Field Trials Derby, Qualifying, Open, and Amateur
- 2. Rules and format of a Qualifying stake, from both the perspective of participating in one and for putting one on
- 3. Typical Qualifying set ups and how to train for them.
- 4. What is being judged

Also included will be information on differences between hunt tests and field trials in terms of series setup, rules and attire for handlers, concepts like 'retired gunners', and a little bit about the titling structure for field trials. Bring your questions!

Following the seminar / demonstration part of the program, Brady will set up and allow everyone to run their dogs on both marking and blind set ups. Coaching and assistance will be provided, and set ups can be broken down as necessary to assist with the level of the dog and handler.

### AKC Advanced Retriever Hunting Test Seminar for Judges

Saturday and Sunday, March 12-13, 2022, 8 am to 4 pm

**LOCATION SATURDAY**: Conference room, Comfort Inn, 2811 Decatur Pike, Athens, TN 37303

LOCATION SUNDAY: Cory Smith Farm, 245 County Road 319, Niota, TN 37826

**SEMINAR DESCRIPTION:** This seminar has been designed for judges that have attended the basic one-day AKC Hunting Test Seminar and have attained some judging experience through apprenticeships and/or actual judging.

This seminar is, however, open to anyone and can be quite beneficial in helping handlers to better understand judging criteria and considerations. We encourage ETRC Members to take advantage of the opportunity to attend this seminar even if you never plan to judge a hunt test!

This seminar WILL NOT count as the initial one-day AKC Basic seminar, which covers different subject matter. This seminar has been designed to enhance the Retriever Hunting Test Program by assuring the regulations, guidelines, and test requirements are understood and are being met, and that the standards for all levels of testing are being maintained through fully knowledgeable judges.

**AREAS COVERED:** Purpose of the Retriever Hunting Tests—what to expect when you are asked to judge — Judge's responsibilities— Pre-Test Responsibilities— Planning the Hunting situation — Judge's Authority — The day of your Test — Dog's abilities — Scoring.

FORMAT: This is a two-day seminar with one day spent in the classroom indoors and one day spent outdoors developing and running tests at the three levels — Junior, Senior, and Master. Participants will have the opportunity to watch, judge and score each dog's performance on the tests designed. We will then have the time to critique each dog's performance and why the scores were assigned. Three dogs will be run at each level.

**PRESENTER:** Russ Reavis, AKC Representative.

New Field Trial Champion! Jake Greenwell's dog Eva (FC Troublesome Canadian Huntress) earned her Field Champion (FC) title in November 2021 by winning her second Open stake with Jake handling. Earning an FC title is a huge deal, so major congratulations to Jake, co-owner John Broucek, and also to Brady Collins, who trained her and handled her to some of her points. This win not only earned her the FC title, it made her eligible for the National Open Field Trial Championships, where Brady handled her successfully through the 3rd series. Even getting an invitation to attend this event is huge, so another round of congratulations all around.

Eva was whelped on March 29, 2015. She made the 2017 National Derby List with 16 derby points and won her first Qualifying Stake at 25 months. She is a littermate to the dog who was the 2017 National High Point Derby dog with 77 Points, and is a sibling or littermate to 4 other dogs who made the Derby List and QAA. In addition, Eva has proven herself as a producer. She has had three litters to date, with a number of pups who have already made the National Derby List and who are QAA. Her most recent litter was whelped just recently.

### Long-Time ETRC Member Fay Norwood Dies

We were saddened to read in the MNRC Blog that our long-time member Fay Norwood died recently. Fay's membership lapsed about 3 years ago, but before then she had been to virtually every one of our hunt tests for many, many years — usually marshaling as well as competing in the Master Stake. She was an amazing lady! The information below is reprinted from the MNRC post.


The MNRC community is saddened to learn of the passing of longtime MNRC owner-handler Fay Norwood of Tennessee. Fay Council Norwood, 91, died peacefully at home, with her beloved dog, Sonny, at her side, on December 18, 2021. Fay was born on October 9, 1930 to Henry Marvin Council and Bessie Loyd Council. She grew up in Atlanta and earned a bachelor's degree in Chemistry from the University of Georgia. She worked as a chemist for Tennessee Chemical Company, where she met Samuel L. Norwood III. They married in 1959 and had two children: Vicky and Sam. The family moved to the Basin in 1969 where Fay facilitated tree houses, dance and music lessons, Boy and Girl Scouts, sledding outings, bridge club events, and all things school-related.


After her children left home, Fay received her first yellow Labrador Retriever, Roux, and trained him as a hunting dog. When Roux grew older, she added JJ to the family. Fay traveled all over the US to train and enter hunting trials. She led JJ (Norwood's Ocoee JJ) to eight passes as a Master National Hunter, placing him in the Hall of Fame. Only five dogs have successfully completed nine passes and JJ is one of three to successfully complete eight passes. After JJ's death, Fay acquired Sonny, who has been her faithful companion for the past 12 years.

Fay was preceded in death by her parents, her husband Sam in 1981, and her son-in-law, Dr. David Kahler, in 2020. She is survived by her daughter Dr. Vicky Norwood and granddaughter Katherine Kahler, both of Charlottesville, VA; and son Sam (Elisabeth) and grandchildren Emily, Robert, and Will, of Bettendorf, IA. The family would like to express its deep appreciation to Toshia Worley and her team for providing Fay with loving home care over the past three years.

### ETRC Board Meeting, Wednesday, 1/19/22 Pegasus Technologies Building, Lenoir City, TN

Absent, excused: J. Michael Evans, Jeff McNutt, Denise Chambers

Others Members Present: None

A quorum is 50% of the Board. Therefore, a quorum of the Board was present with 8 people present. The meeting was called to order at 6:39 p.m.

#### Officer's and AKC Delegate's Reports

President's Report: None.

Secretary's Report. Karen Edwards.

- → Minutes: Last meeting was 12/6/21; minutes approved by a majority of Board members and sent to the club website on 12/12/21. Luke moved that we dispense with reading the minutes out loud, and vote formal approval. Jim seconded the motion which passed unanimously.
- Correspondence: None to report.
- Membership: Current 2021/22 membership is 58 including new member in December. Six people so far have renewed or joined for 2022, plus one who paid twice last year and asked for his check to be carried over for this year, and two free comped memberships. The membership year doesn't start until March 1 so these are all early.

*Treasurer's Report:* Current balance is \$37,625.07. Only recent activity was payment of webhosting fees, \$203, for 7/2-12/31/21. Michele handed in receipts for AKC tests in April and May that she paid, plus postage receipt for the AKC medallion. Karen will cut her a check to reimburse her for these expenses.

#### **Old Business**

- 1. Banquet: February 18 (Friday), 6:30 p.m., Bearden Banquet Hall (Buddy's BBQ). The room is reserved, contract signed, and \$250 deposit has been paid that will be applied to menu. We reviewed the menu and decided on the following: The Dinner Buffet with Chicken Cordon Bleu and Grilled Beef Tenderloin; garden salad, French Green Beans Almondine and Twice Baked Potatoes; Banana pudding for dessert. Complimentary beverages will include sweet and unsweet team, coffee, and water. Beer will be available at \$4 a can for anyone who wants to buy it. The food, exclusive of the beer, will cost \$27.95 per person which the club will pay. Alan will call the Banquet Hall and relay these choices; we will need to provide them with numbers of attendees about a week before the event. Karen will include info in the February 1 newsletter asking for RSVPs (we have 12 already) and will follow this up with an email to the membership about a week later seeking final RSVPs.
- 2. Hunt Tests in 2022. we have the following dates and locations:
  - April 19-20, Tuesday/Wednesday: Double Junior / Senior, Brian Caldwell's farm. AKC fees paid, events #2022-3528-13&14. On Entry Express. Caldwell is OK with us using his farm.
  - May 28-29, Saturday/Sunday: 1 flight Master, double Junior, double Senior at Hiwassee, plus a second flight of Master at Brian's. AKC fees paid, events #2022-3528-06 & 07. On Entry

Express. Caldwell is OK with us using his farm; Michele has applied for Hiwassee but hasn't heard back yet and will follow up.

- September 20-21, Tuesday / Wednesday: Midweek Master Only (66 dogs), Brian Caldwell's. On Entry Express, Caldwell is OK with using his farm, AKC application not yet completed.
- October 23-24, Saturday / Sunday, 2 flights Master, double Junior, double Senior. On Entry Express, AKC application not yet completed. Location not yet pinned down -- possibly at Ken Campbell's, possibly somewhere else.
- November 1-2, Tuesday / Wednesday, single flight Master, Brian Caldwell's. On Entry Express, Caldwell is OK with using his farm, AKC application not yet completed.

Mike Evans will talk to Ken Campbell about possible use of his farm in the fall. If this farm isn't available, we will need to check other options. Michele will make application to AKC as we get things firmed up. Judges have not yet been selected for anything and need to be worked on; same with ducks. J. Michael Evans is researching alternate duck suppliers for early tests.

- 3. Duck Pen: Mike and Cory Smith reported that a group went out there and agreed to build the duck pen inside the barn / kennel building. It will be 10' wide, about 38' long, and 30' of it will be under the existing roof with the remainder (the trench with drain for the duck pond) will be out in the open. Electricity and water are already there in the building. Cory has been working on cleaning the area out and is almost done, then he will use his tractor box scraper to level it out a bit. Apparently, if we use fiberglass concrete, we don't have to have gravel and rebar; we discussed trying to find a contractor to do the concrete base, pond trench and drain, and us just doing the chain link fending. Next steps: research some concrete contractors in the Sweetwater area and try to get this done ASAP.
- **4. Equipment:** Progress on selling L7 trailer: Mike Evans / Mike Smith. Mike S. had a possible buyer who backed out because it was only 20' long and he needed a 24' long trailer. J. Michael has advertised in Craig's list but apparently didn't get any interest. Will try again, maybe use Facebook Marketplace.
- 5. Judges Seminar, March 12-13: contract signed with hotel and agreement with Cory Smith for having the practical session at his place. Brochure is out on EE, AKC website, and posted in Newsletter last two months
  - Registration to date: 4 people: the Vencilles, Denise Sejalon, Kathy Poole Price. Mike and Donna Smith signed up at the meeting, others indicated their interest. People can apply directly through EE but so far, no one has.
  - Cost, food, motel rooms, registration fee, member perks: As a reminder, we have to pay \$500 to AKC, plus additional \$25 for every participant above 20. We also have to pay \$225 to the Comfort Inn Athens for use of the room, and also possibly \$94 a night for Russ Reavis at the Inn for Friday and Saturday nights. Add in some donuts and snacks, and we are at \$1000 cost to us as a club. We will get \$500 or \$600 back from MNRC afterwards (our approved grant).
  - Russ Reavis's motel fees may or may not be provided by AKC as part of the cost of putting on the seminar. Alan doesn't have any info yet on whether this is covered or we have to pay it, but Russ has mentioned that Jerry Mann might come along to help.
  - Registration fee: \$50 fee for registration, including members. For those people who were club members as of December 1, 2021, who sign up, pay the registration fee and actually show up at the seminar, we will hand them back their checks so their attendance will be free.
  - We will provide mid morning/ mid-afternoon snacks (donuts etc.) and lunches both days maybe pizza at the motel on Sunday and a sack lunch of some sort at Cory's on Sunday. Final decisions on this pending how many people end up registering.

- Other Logistics: AKC requires the following --
  - Club representative must meet with Reavis at both the Inn and at Cory's on Friday afternoon beginning around noon. Alan will do that.
  - Classroom location must have extension cord with power strip, projector screen or white wall for the presentation, and a white board with markers, or a flip chart stand. Alan will check with the inn to make sure they have these items.
  - Manpower and equipment needed to set up three Master (/senior/Junior) level testing scenarios on Friday at Cory's, assisting Russ Reavis: Alab, Mike Evans Mike Smith, and Jim Pearce.
  - Ducks: If we can't find live ducks, AKC will grudgingly let us use frozen ones. Alan thinks we can empty out our freezers and have enough ducks otherwise; Mike Evans is still looking into whether or not we can locate any live ducks. Total number needed is probably around 25 with at least 9 alive.
  - ◆ Jeff McNutt said he will locate two shooters for the live -- he was not present so we don't have an update on this.
  - Bird techs: we decided to hire 3 people to be out in the field so club members don't have to. Mike Smith will ask Brian Caldwell about his two duck techs, Karen will ask Lois about using her nephew Gavin.
  - Dogs: We have to supply 3 Junior dogs and handlers, 3 Senior dogs and handlers, and 3 Master dogs and handlers. Per AKC, these can be handled by participants if necessary. So far, we have three Junior dogs, 2 senior dogs, and one Master dog pinned down, will be looking for some others.

#### 6. Winter training schedule:

- January 23, 1:00 p.m., Sunday, at Cory's: transition drills and let dogs try them with advice from the presenters. Mike Evans and Alan, the presenters, suggested that we delay this event because they weather is supposed to be cold, moist, and miserable on Sunday. We agreed on a new date of March 20; Karen will notify the membership via email and will post new info in the newsletter and on the website.
- ♦ Saturday, February 26, 2022, 1 p.m., Dogtown: Brady Collins, Jake Greenwell, and John Broucek to present a seminar on Field Trials. Working with them on topics to be covered, and a possible raindate.
- 7. Club Trial: April 2: Location is still to be determined. Mike Smith will check with Caldwell to see about use of his place; Alan or Mike Evans will check with Darryl Miller to see if his place might be available. We will only have one club trial this spring.
- **8. Ribbons:** K still needs to order 200 Master ribbons, 100 senior ribbons and 200 Junior ribbons, purchase approved at last meeting. Sale lasts through February.

#### **New Business:**

1. New Member: for first reading:

ed in AKC hunt tests and dog training, judging & judging clinics, breeding, and belong to DU and the Yadkin River Retriever Club, volunteer for 'whatever is needed'.

They have requested Alan Bruhin and J. Michael Evans as sponsors. Both agreed to serve. Luke moved we accept them as provisional members, Michael. seconded, and the vote was unanimous. Karen will send them names and contact info for their sponsors; sponsors will have access to the new members' contact info through these minutes when completed. Alan noted that the Vencilles have a large property in lower Virginia, about 3.5 hours away from here, which they have mentioned we could use for one of our events possibly. Depending on what Hiwassee and Ken Campbell decide about their properties, this might be a solution although it's not ideal.

#### Any other new business?

**Adjourn:** There being no other new business, Luke moved that we adjourn. Jim seconded the motion which then passed unanimously. The meeting was adjourned at 8:20 p.m.

- We sold the Lucky 7 trailer. We still have a few small pieces of equipment for sale; if you are in the market for a duck drier, shotgun, gun stand, metal direction sign, or a Ghillie blanket, please email for info and price.
- Hiwassee is confirmed as the location for our big Spring Hunt Test over the Memorial Day weekend.
- We are getting estimates for pouring the concrete for the duck pen at Cory's.

Numbering System: When I first took over the newsletter, I just continued on with the volume # from the last issue, then upped it by one every year. But, it makes no sense, and doesn't reflect how many years of newsletters we have anyway. So beginning with the January 2020 issue, the volume number is the last two digits of the year, in Roman numeral format — so this is now Volume XXII (for 2022).
